Episode 51: Know The Rules! Assigned Security Responsibility

In this week's "Know The Rules!" I am diving a little deeper into the second standard in the Administrative Safeguards section: Assigned Security Responsibility. There are no separate implementation specifications for this standard.

The standard requires that Covered Entities (CEs) or Business Associates (BAs):

"Identify the security official who is responsible for the development and implementation of the policies and procedures required by this subpart [the Security Rule] for the entity."

The purpose of this standard is to identify who will be operationally responsible for assuring that the CE complies with the Security Rule.

Customer Showcase: Mohave Community College (AZ)

Every month we give a little bit of love to one of our valued customers! This month we celebrate the awesome Nursing **Staff at Mohave**

Community College (AZ).

Mohave Community College (MCC) was established as a county college by a vote of the people in October 1970. Recognizing the vastness of the service area, the first Board of Governors made a commitment to establishing three main campus sites. In June 1971, J. Leonard and Grace Neal donated 160 acres of land where the college's first facilities were developed.

In 1981, MCC received full accreditation from the North Central Association of Colleges and Schools (NCA). In 1982, the college received full accreditation of its associate degree in Nursing. In the same year, the Board of Governors approved the development of a telecommunications system to link the three main campuses together electronically.

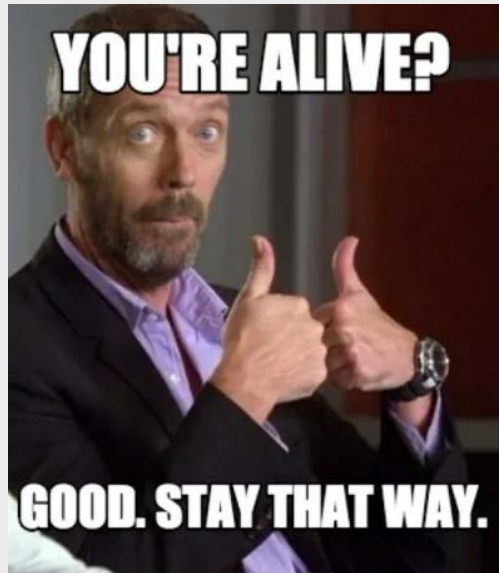
When it opened in 1971 the college offered just 27 courses. Today MCC offers more than 60 degree and certificate options for students, and the tuition rate has held steady at \$81 per credit hour making it an extremely affordable higher education option for the people of Mohave County and the tri-state region.

Nursing Program: The ultimate goal of the Nursing Department is to prepare graduates for safe and effective clinical practice. The Nursing programs are offered countywide with classes in the southern part of Mohave County in Kingman, Lake Havasu City and Bullhead City, and the northern part of the County in Colorado City. Students successfully completing the program will be

eligible to take the National Council Licensure Examination for Registered Nurses (NCLEX- RN). Students at Mohave Community College had over 75% NCLEX-RN First Time Pass Rate in 2021-2022.
